RESOLUTION NUMBER 2007-197

AUTHORIZING THE BCDA MANAGEMENT AND HOLDINGS INC. OFFICERS AND EMPLOYEES TO FILE CRIMINAL COMPLAINTS BEFORE THE JUDICIAL COURT HAVING JURISDICTION AGAINST JOSEPH PANAGA, ET. AL. FOR ALLEGED COMMISSION OF THEFT AND PILFERAGES OF EQUIPMENT AND ACCESSORIES

WHEREAS, the NAPOLCOM and the BCDA executed a Memorandum of Agreement dated May 14, 1998 for value-for-value land swap of respective real properties in Fort Bonifacio and Camp Bago Bantay, Quezon City;

WHEREAS, a Memoranda of Agreements dated May 14 and 18, 1999 executed by NAPOLCOM and BCDA provided for 2250 housing units to officials/personnel of NAPOLCOM/PNP;

WHEREAS, an estate development management office was established to manage and operate the housing units in behalf of NAPOLCOM;

WHEREAS, there were reports of an increase in the incident of theft and pilferages of equipment and other properties in the NAPOLCOM Housing Project in Pamayanang Diego Silang, Taguig City;

WHEREAS, the Estate Manager of Pamayanang Diego Silang, reported to the Commission the arrest of the following individuals caught in the act of stealing electrical wires at the 5th Floor of MB No.3 on March 16, 2007, namely;

1. Joseph Panaga
2. Louie Lucero
3. Sander Buan
4. Certain "Nestor", "Tony" and Doroman"

WHEREAS, there is a need to authorize the BMHI to file the appropriate criminal charges against the suspects before the Prosecution's office/court.

NOW, THEREFORE, the Commission **RESOLVES TO AUTHORIZE, AS IT HEREBY AUTHORIZES**, the BMHI to file criminal charges in Prosecution's office/court against the following individuals, namely:

2. Louie Lucero
3. Sander Buan
4. Certain "Nestor", "Tony" and "Doroman"
