RESOLUTION NO. 2007-217

APPROVING THE CREATION OF DINAGAT ISLANDS PROVINCIAL POLICE OFFICE (PPO) AND RESTRUCTURING OF JURISDICTION OF DINAGAT ISLANDS AND SURIGAO DEL NORTE PPO

WHEREAS, Section 14 of Republic Act No. 6975, as amended, provides that the National Police Commission (Napolcom) shall exercise administrative control and operational supervision over the Philippine National Police (PNP).

WHEREAS, the PNP submitted for consideration of the Commission NHQ-PNP General Orders Number DPL 07-02 providing for the activation of Dinagat islands Police Provincial Office (PPO) as a Type "C" PPO located at the Municipality of San Jose, CARAGA and restructuring of jurisdiction of Dinagat Islands and Surigao Del Norte PPO, as follows;

WHEREAS, the creation of Dinagat Islands PPO in CARAGA is in connection with the enactment of Republic Act No. 9355 entitled "*An Act Creating the Province of Dinagat Islands*" dated July 24, 2006 and its subsequent ratification thru a plebiscite on December 2, 2006.


WHEREAS, the creation of the Dinagat Islands PPO shall likewise create the Dinagat Islands Provincial Mobile Group (PMG) also known as 1407th PMG which shall be headed by a **Police Commissioned Officer (PCO)** with the rank of Police Superintendent (PSUPT).

WHEREAS, initial personnel, equipment and facilities needed for the creation of Dinagat Islands PPO shall be provided by the Regional Director of Police Regional Office (PRO) CARAGA from available resources. Additional requirements shall be submitted to the concerned Directorial Staff at the **PNP, NHQ**.

WHEREAS, the Commission finds merit in the creation of Dinagat Islands PPO in PRO CARAGA as it is in line with the government's effort to improve peace and order in the country;

NOW THEREFORE, the Commission, concomitant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the creation of Dinagat Islands Police Provincial Office (PPO) and restructuring of jurisdiction of Dinagat islands and Surigao del Norte PPO as provided under NHQ-PNP General Orders Number DPL 07-02, herein attached as "TAB 1".
