RESOLUTION NO. 2007 - 225

**DIRECTING THE DIRECTOR, PNP DIRECTORATE FOR LOGISTICS (DL) TO
RECALL ALL V-150s ASSIGNED TO THE REGIONAL MOBILE GROUPS (RMGs)
AND THE SPECIAL ACTION FORCE (SAF) FOR REHABILITATION AND REPAIR
TO ENSURE OPERATIONAL READINESS**

WHEREAS, Section 14 of Republic Act (R.A.) No. 6975, as amended, provides that the National Police Commission (Napolcom) shall exercise administrative control and operational supervision over the Philippine National Police (PNP):

WHEREAS, in addition to the statutory functions of the PNP under R.A. No. 6975, as amended, the Philippine National Police is mandated under Executive Order No. 546, dated July 14, 2006 to undertake active support to the Armed Forces of the Philippines on matters involving internal security, specifically in combat operations, to suppress insurgency and other serious threats to national security:

WHEREAS, the PNP has tactical assault vehicles (V-150) numbering to 28 that are assigned to the following Regional Mobile Groups (RMGs) and the Special Action Force (SAF);

WHEREAS, there is an imperative to ensure the superiority and combat operational readiness of all these V-150s with the end in view of achieving maximum effectiveness in the implementation of the program on Internal Security Operation as mandated under E.O. No. 546;

NOW, THEREFORE, BE IT RESOLVED AS IT HEREBY RESOLVED, to direct the Director of the PNP Directorate for Logistics (DL) to recall all V-150s assigned at the Special Action Force (SAF) and Regional Mobile Groups (RMGs), whether serviceable or unserviceable, for complete worthiness assessment, to cause the immediate rehabilitation and repair of unserviceable units and make them operational within sixty (60) working days from receipt of the combat vehicles, and to ensure regular maintenance of all V-150s.
