RESOLUTION NO. 2007- 226

**AMENDING ITEM NO. 6 OF NAPOLCOM RESOLUTION NO. 92-36 ENTITLED
“APPROVING THE REVISED ORGANIZATIONAL STRUCTURE OF THE
PHILIPPINE NATIONAL POLICE (PNP) AND PROVIDING POLICIES AND
GUIDELINES IN THE IMPLEMENTATION THEREOF”**

WHEREAS, exercising its powers of administrative control over the PNP, the National Police Commission issued Resolution No. 92-36 on October 10, 1992 which approved the Revised Organizational Structure of the PNP and provided policies and guidelines in the implementation thereof;

WHEREAS, said Resolution, specifically Item No. 6, states that:

“6. Elements of the national administrative and operational support units who are assigned or detailed in the regions shall be under the operational control of the Regional Director.”

WHEREAS, these administrative and operational support units have been created and organized for the purpose of enhancing police operational efficiency and effectiveness;

WHEREAS, in consonance with the needs of the changing times, the urgency of addressing the problems of criminality, lawlessness and insurgency that transcend regional boundaries, the imperative to improve police operations and delivery of police services, and the requirement to alleviate the heavy law enforcement responsibilities of regional, provincial and city/municipal police, the functional relationships of the National Support Units (NSUs) and Police Regional Office (PRO) must be clarified;

NOW, THEREFORE, the Commission pursuant to its constitutional mandate to administer and control the Philippine National Police **HAS RESOLVED AS IT HEREBY RESOLVES**, to transfer the supervision and control of the personnel of the Administrative and Operational Support Units who are assigned or detailed in the regions to the Directors of these support units at the National Headquarters of the Philippine National Police.

RESOLVED FURTHER, that the Chief, PNP shall issue the implementing rules and guidelines as maybe necessary to carry out the provisions of this Resolution.

All issuances inconsistent with this Resolution are superseded or amended accordingly.
