**RESOLUTION NO. 2008 - 230**

**GRANTING THE CHIEF, PNP THE AUTHORITY TO FILL-UP ONE THOUSAND SIX HUNDRED FIFTY FOUR (1,654) VACANCIES FOR THE RANKS OF POLICE INSPECTOR AND POLICE SENIOR INSPECTOR UNDER THE CY 2008 LATERAL ENTRY PROGRAM**

**WHEREAS**, Section 14 (a) of Republic Act No. 6975, as amended by Section 5 of Republic Act No. 8551, provides that the Commission shall exercise administrative control and operational supervision over the Philippine National Police;

**WHEREAS**, the Chief, PNP requested authority to fill-up one thousand six hundred fifty four (1,654) vacancies for the ranks of Police Inspector and Police Senior Inspector via lateral entry, to wit:

**WHEREAS**, the filling-up of vacancies is intended to maintain the pyramidal rank structure of the PNP which was affected due to the promotion and normal attrition of Police Commissioned Officers (PCOs);

**WHEREAS**, the said quota shall be for Technical Service Officers and Line Officers and shall be allocated to the different Police Regional Offices (PROs) and selected National Support Units (NSUs);

**WHEREAS**, after consideration of the proposal, the Commission finds the same to be in order considering that the filling-up of such vacancies shall reduce the number of vacancies for the said ranks to conform with the PNP pyramidal rank structure provided under Napolcom Resolution No. 2001-070 and that the said filling up of vacancies shall not entail additional funding requirement;

**NOW THEREFORE**, the Commission in the exercise of its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO GRANT, AS IT HEREBY GRANTS**, the Chief, PNP the authority to fill-up one thousand six hundred fifty four (1,654) vacancies for the ranks of Police Inspector and Police Senior Inspector under the CY 2008 Lateral Entry Program.

**RESOLVED FURTHER**, that the distribution of quota shall be as follows:
