RESOLUTION NUMBER 2008-296

AUTHORIZING THE BASES CONVERSION DEVELOPMENT AUTHORITY (BCDA) TO UTILIZE A CERTAIN AMOUNT OF THE SPECIAL ACCOUNT FUND FOR THE REHABILITATION AND IMPROVEMENT OF NAPOLCOM REGIONAL OFFICE III BUILDING AT REGIONAL GOVERNMENT CENTER, MAIMPIS, SAN FERNANDO, PAMPANGA

WHEREAS, a Memorandum of Agreement (MOA) dated May 14, 1999 between the National Police Commission (NAPOLCOM) and the Bases Conversion Development Authority (BCDA) provided among others, the establishment of a Special Account for the exclusive benefit of NAPOLCOM where collections/proceeds from the award/sale of the housing units in Pamayanang Diego Silang to the personnel of NAPOLCOM/PNP shall be deposited less administrative expenses;

WHEREAS, the Special Account Fund can be utilized for NAPOLCOM priority estate development projects and development of all NAPOLCOM real properties, the disbursements of which is made only upon the written approval of the NAPOLCOM Chairman or his duly authorized representative, in accordance with existing laws, rules and regulations;

WHEREAS, NAPOLCOM Regional Office III is temporarily utilizing an existing building owned by Police Regional Office III (PRO III) inside Camp Olivas, San Fernando, Pampanga;

WHEREAS, the aforementioned regional office has an existing unfinished/unoccupied building construction located at the Regional Government Center with a lot area of one thousand five hundred square meters (1,500 sq.m.) covered by a Deed of Assignment executed by and between the Governor of Pampanga and NAPOLCOM Regional Director;


WHEREAS, there is a need to rehabilitate and improve the unfinished/unoccupied building located at the Regional Government Center to have sufficient office space conducive for the administration and operational requirements of NAPOLCOM Regional Office III;

WHEREAS, the BCDA Management and Holdings, Inc. (BMHI), which was designated Estate Development Project Manager for NAPOLCOM Projects pursuant to BCDA Board Resolution No. 2008-01-004, prepared the necessary designs and specifications for the rehabilitation and improvement of the unfinished/unoccupied building estimated to cost Php12,050,000.00;

NOW, THEREFORE, the Commission **RESOLVES, AS IT HEREBY RESOLVED**, to authorize BCDA to utilize the amount of Twelve Million Fifty Thousand Pesos (Php12,050,000.00) portion of the Special Account Fund for the

rehabilitation and improvement of NAPOLCOM Regional Office Building (Region II) located at Regional Government Center, Maimpis, San Fernando, Pampanga.


